





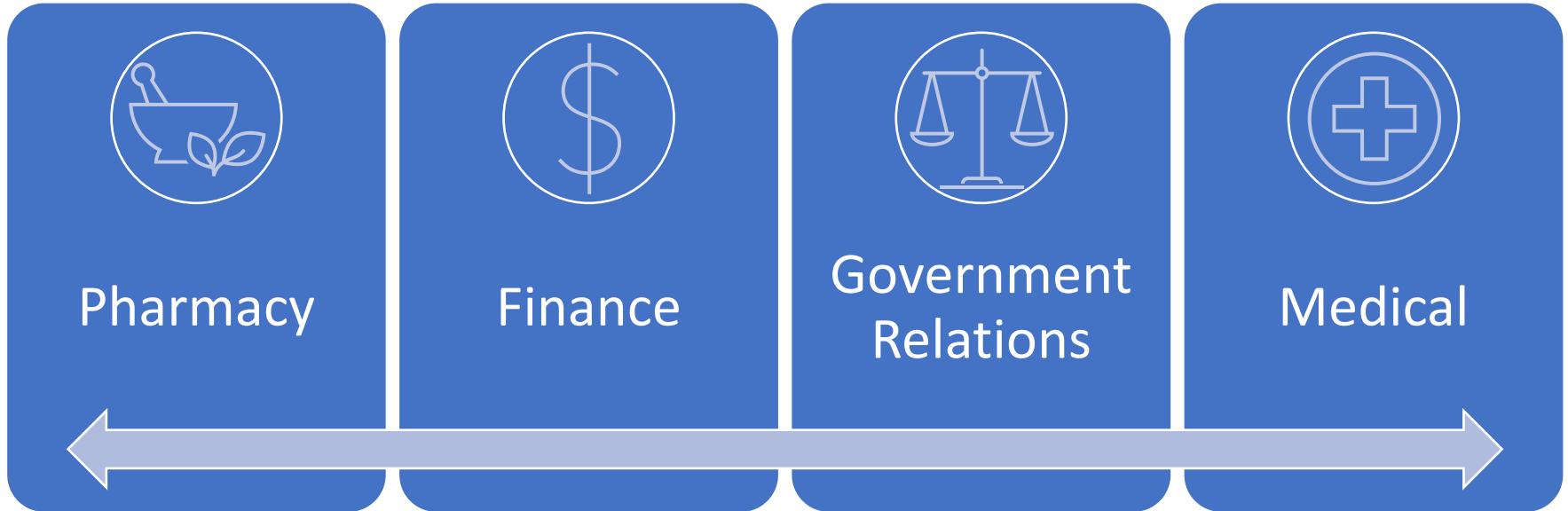
## **HCT Work Group Mission**

# Develop Federal Policy Recommendations

---

- Goal: Support equitable access across states to high-cost drugs/therapies particularly for children on Medicaid
- To date – Met with CMS Innovation Center to discuss model and pediatric impact and perspective
- This year, work to develop federal policies:
  - Foundational conversations on existing models/policies being discussed– CMS Innovation Center, National Association of Medicaid Directors, MACPAC and others
  - Established a federal policy subgroup made up of 10 GRs utilizing hospital experts as needed
  - Compiling list of existing policies being discussed at the federal level and using hospital input on state policies to inform our work
  - Recommendations go to broader workgroup, GR subcommittee, Public Policy Committee and Board

# High-Cost Therapies (HCT)

---

- Engaging with CMS Innovation Center on access model focused on sickle cell.
  - Encourage your state to participate.
- Utilizing existing HCT workgroup for expertise and input – operational, financial, government relations (GR) leaders involved.
- Created a GR subgroup to produce potential federal policy proposals to ensure equitable support for HCT.
  - Focusing on HCT, Medicaid to start.
  - Reviewing existing federal and state policies to inform our work and discuss potential alignment with other stakeholders.
  - Provide a menu of options to discuss with federal policymakers by early next year.
  - Proposals will be vetted through CHA's governance process.
